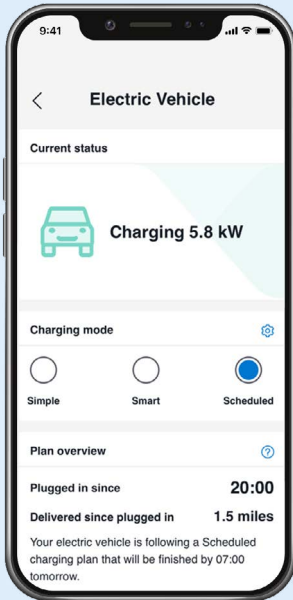

All participants must have an existing solar panel system.

Moixa and Alfen are launching a trial for 10 lucky customers to receive a free smart Alfen charger, optimised by Moixa's smart GridShare software, to test their new smart charging solution. Through Moixa's GridShare software, personalised charging plans will be sent to the smart Alfen charger, to adjust the vehicle's charging behaviour, ensuring that your vehicle is primarily charged through self-generated solar energy or from the grid at cheaper rates through time of use tariffs, if you have one. GridShare takes into account household energy consumption patterns, predicted solar generation and a household's energy tariff, to create a personalised charging plan that works best for you.

**As a part of the trial you'll be able to control and monitor the smart charging of your vehicle from the Moixa GridShare app, where you can choose from Simple, Scheduled and Smart modes to charge your car:**

#### **Simple mode**

Starts charging your electric vehicle immediately once plugged in.

#### **Scheduled mode**

Allows you to set a charging routine for individual days of the week by setting charge events for when you'd like your vehicle ready by.

#### **Smart mode**

Once plugged in, Moixa will calculate the optimal charging plan based on your household energy consumption, energy tariff, predicted solar generation and preference settings. For those with fixed-rate energy tariffs, the predictions will also be simulated to optimise against the time-of-use tariffs. The simulation may impact the time when your car is charging within your preference settings.

For the first month of the trial, Moixa will conduct remote testing of the charger, network, and electric vehicle charging. During this one month period, the charger will act as a regular non-smart charging system and will charge immediately when a car is connected similar to simple mode. Participants might be contacted to perform basic testing of our smart charging services, at their convenience during this first month.

The app will be available from the second month of the trial which is why your charger will be set to simple mode.

Later on in the trial Moixa will test how smart charging can perform grid services. More information about this will be available closer to the time.

The trial is planned to run until the end of 2020. After this date all participants will be able to choose whether to continue subscribing to Moixa's smart charging service. The smart Alfen charger will remain free at the property, and continue to function as a regular electric vehicle charger.

Thank you for expressing interest in becoming a trial participant for the Alfen Smart Charger System (the “**Product**”). In order to proceed with the process we will need your acceptance of the terms and conditions of the trial as outlined below.

## Terms and Conditions

The terms and conditions are to be considered in addition to any existing end user agreement entered into between you, the customer (“**you**”) and Moixa and these terms and conditions prevail where there is any discrepancy between the two.

### Period of Trial

The trial period will last for a period of 5 months commencing from the date on which the Product is commissioned (the “**Trial Period**”). Your end user agreement (to be provided post system install) will be amended so that the first paragraph of the section headed “Term and Termination” is deleted and replaced with “This End User Agreement will continue for a trial period of five (5) months from the Start Date. At the end of this trial period, you will be given the opportunity to continue your relationship with Moixa pursuant to this End User Agreement for a period of thirty six (36) months minus five (5) months (the “**Term**”) and thereafter, it will be automatically renewed for successive periods of twelve (12) months unless you wish to discontinue.”

### Trial Termination

You may terminate your participation in the trial at any time during the Trial Period by giving Moixa at least five (5) days’ notice. You will be responsible for any fees relating to the deinstallation of the Product from your property.

### Lost Savings

Moixa will be actively monitoring the Product’s functionality and will use its best endeavours to correct any issues during the Trial Period. However, there may be some loss in savings due to failure of the Product’s smart functionality. Any loss in savings would be insignificant in comparison to the value of the hardware we have supplied to you free of charge.

### Flexibility Services

Your Product may be used to test flexibility services during the scheduled and smart charging stages of the Trial Period. This involves pausing the charging of your electric vehicle for up to thirty (30) minutes; you will be notified in advance of any testing.

### Warranty

Inclusive of this trial are three warranties covering all equipment installed. This includes the Alfen 3 Year warranty

covering the Alfen charger unit, Moixa 3 Year warranty covering the Moixa hub and accessories, and the Stratford 3 year workmanship warranty. All support is provided via Moixa.

### Funding

The installation cost as part of this trial is partially funded by the OLEV EVHS grant where you are eligible. If eligible you will be required to provide all of the information for a successful grant application.
